

TOWNSHIP OF WINFIELD – ORDINANCE # 434 TO PROVIDE FOR THE RESURFACING FROM WAVECREST AVE. TO SEAFOAM AVE. PHASE II IN THE TOWNSHIP OF WINFIELD, MAKING AN APPROPRIATION AND AUTHORIZING THE FINANCING THEREOF

BE IT ORDAINED by the Township Committee of the Township of Winfield in the County of Union, New Jersey, as follows:

SECTION 1 Wavecrest Ave. to Seafoam Ave. Phrase II shall be improved by resurfacing the streets in the Township.

SECTION 2. The estimated cost to the Township of Winfield for the aforementioned project is Two Hundred Ten Thousand Dollars. (\$210,000.00)

SECTION 4. There is hereby appropriated the sum of One Hundred Ninety Five Thousand Dollars (\$195,000.00) made available to the Township of Winfield by the New Jersey Transportation Trust Fund Authority Act and Fifteen Thousand Dollars (\$15,000.00) which has been made available in the Capital Improvement Fund in a previously adopted budget.
