

TOWNSHIP OF WINFIELD — ORDINANCE # 443 TO PROVIDE FOR THE RESURFACING FOR VARIOUS STREETS IN THE TOWNSHIP OF WINFIELD, MAKING AN APPROPRIATION AND AUTHORIZING THE FINANCING THEREOF

BE IT ORDAINED by the Township Committee of the Township of Winfield in the County of Union, New Jersey, as follows:

SECTION 1 Wavecrest Ave. to Seafoam Ave. shall be improved by resurfacing the streets in the Township.

SECTION. The estimated cost to the Township of Winfield for the aforementioned project is Three Hundred and Eleven Thousand Dollars. (\$311,000)

SECTION. There is hereby appropriated the sum of Three Hundred and Eleven Thousand Dollars. \$290,000 made available to the Township of Winfield by the New Jersey Transportation Trust Fund Authority and \$21,000 by the township Capital Improvement Fund.

I, Leonard Ho- Winfield Township CFO, certifies that there is sufficient funds available to award bid for project aka "Resurfacing seafoam Avenue & Pacific Drive" in the total amount of \$298,000, of which, \$290,000 is from Department Of Transportation grant and \$8,000 from Capital improvement Fund. Availability of funds is subject to final grant award amount.
