

AN ORDINANCE TO AMEND AN ORDINANCE REGULATING THE ISSUANCE  
OF DOG LICENSES IN THE TOWNSHIP OF WINFIELD AND FIXING THE  
FEE FOR SUCH LICENSES.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WINFIELD, N.J.

SECTION 1: Section 1 of an Ordinance amending an Ordinance relating to the licensing of dogs and fixing the fee for such license in the Township of Winfield be and the same is hereby amended as follows:

The Township Committee of the Township of Winfield does hereby establish a dog license for any dog owned, harbored or kept within the municipal limits of said Township. Said license shall be secured annually by any person owning, harboring or keeping any dog or dogs within the municipal limits of the Township of Winfield. The fee for said license or any renewal thereof shall be the sum of Two (\$2.00) Dollars for each dog licensed and said fee shall be paid at the time of issuance to the person issuing such license in behalf of the Township of Winfield. The aforementioned license fee shall be the property of the Township of Winfield and any person collecting the same in behalf of the Township shall immediately forward it to the Treasurer of the Township to be deposited in the funds of the Township. In addition to the collection of the aforementioned license fee there shall also be collected from any person securing a license or any renewal thereof the additional sum of Twenty-five (\$.25) Cents and being the State of New Jersey rabies control tax and which sum so collected shall be transmitted to the State of New Jersey as provided in the Statute in such case made and provided.

SECTION 2: Any person or persons violating the provisions of this Ordinance shall be subject to the fine as set forth in an Ordinance adopted by the Township Committee of the Township of Winfield on June 25, 1942 relating to the licensing of dogs and of which Ordinance this Ordinance is amendatory.

SECTION 3: The provisions of all ordinances heretofore adopted and not inconsistent with the provisions of this ordinance are hereby ratified and confirmed.

SECTION 4: This ordinance shall take effect immediately upon final adoption and publication according to law.
