

AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED "AN ORDINANCE  
FIXING SALARIES OF TOWNSHIP CLERK, TOWNSHIP TREASURER,  
TOWNSHIP RECORDER, TAX ASSESSOR AND COLLECTOR, TOWNSHIP  
ATTORNEY, TOWNSHIP COMMITTEEMEN, COURT CLERK, AND DIRECTOR  
OF WELFARE."

BE IT ORDAINED by the Township Committee of the Township of Winfield that  
the above entitled Ordinance be and the same is hereby amended and revised to read  
as follows:

SECTION 1: That the salaries of the Clerk of the Township of Winfield,  
Treasurer of the Township of Winfield and Clerk of the Magistrate's Court are hereby  
fixed in the following amounts:

- A. Clerk of the Township of Winfield in the sum of \$350.00 per annum.
- B. Treasurer of the Township of Winfield in the sum of \$350.00 per annum.
- C. Clerk of the Magistrate's Court of the Township of Winfield in the  
sum of \$150.00 per annum.

SECTION 2: The above mentioned salaries shall be payable in twelve equal  
monthly installments and said salaries shall be paid from the funds of the Township  
of Winfield by the Treasurer of the Township of Winfield and the aforementioned  
salaries shall be in payment of any and all services rendered by the persons occupy-  
ing the offices mentioned and all fees or other monies received by the said persons  
in the official performance of their duties in such offices shall be considered the  
property of the Township of Winfield and deposited with its funds in such banking  
institution as may be designated by the Township Committee.

SECTION 3: All ordinances or parts of ordinances inconsistent herewith  
are hereby repealed and this Ordinance is intended to amend the provisions of  
Ordinances commonly known as Ordinance No.22, Ordinance No. 35 and Ordinance No.37  
as set forth in the official records of the Township of Winfield.

SECTION 4: This Ordinance shall take effect immediately upon final  
passage and publication according to law.
