

BE IT ORDAINED by the Township Committee of the Township of Winfield:

SECTION 1: "Solicitor" shall mean any person selling goods by sample or taking orders for future delivery with or without accepting an advance payment for the goods.

"Peddler" shall mean any person who goes from place to place by traveling on the streets, from house to house, and carries with him goods, wares, or merchandise of any description for the purpose of selling and delivering them to purchasers.

"Junk Dealers" shall mean any person who goes from place to place by traveling the streets, from house to house, and purchases old papers, rags, metals, or any other type of junk or second hand material.

"Buyer" shall mean any person who goes from place to place by traveling on the streets, from house to house, and offering to purchase old gold, silver, other precious metals, precious stones, china, antiques or other used property or materials.

"Auctioneer" shall mean any person who conducts a sale by selling to the highest bidder.

SECTION 2: No person, firm, partnership, association or corporation, directly or indirectly, shall engage in the usual activities of a Solicitor, Peddler, Junk Dealer, Buyer or Auctioneer without first having obtained a license to engage in such activities from the Clerk of the Township of Winfield and after a full compliance herewith.

SECTION 3: All applications for licenses shall be in writing on forms to be provided by the Clerk of the Township of Winfield and such forms shall be signed by the applicant or the agent of the applicant and where signed by the agent the name and address of the principal and that of the agent shall be fully disclosed. Said application shall be presented to the Clerk and the application shall also further require the disclosure of such information as the Clerk may deem necessary and proper for the purposes of the license indicated. The application shall generally state the name of the applicant and the principal, the correct name under which the business is being operated, the business and residence address of the applicant, and such other pertinent information as may be considered necessary to properly protect the health and safety of the residents of the Township of Winfield.

SECTION 4: All yearly licenses issued pursuant to this Ordinance shall expire on March 1st of each year, unless sooner revoked by action of the Township Committee for good cause.

SECTION 5: The following fees are hereby established for licenses issued pursuant to this Ordinance:

SECTION 6: The provisions of this Ordinance shall be severable and if any of the provisions hereof shall be held to be unconstitutional the decision of the Court respecting such provision or provisions shall not affect the validity of the other provisions herein not declared to be unconstitutional.

SECTION 7: The Department of Police, through the Chief of that Department, may from time to time fix reasonable rules and regulations concerning the use of the licenses to be given under the terms of this Ordinance as the health and safety of the residents of the Township of Winfield may require relating to hours, days or frequency of use of the license mentioned by the persons securing the same.

SECTION 8: Any person, firm, partnership, association or corporation violating any of the provisions of this Ordinance shall upon conviction thereof be subject to a fine not exceeding One Hundred (\$100.00) Dollars and to imprisonment in the County Jail for a term not exceeding sixty (60) days or both such fine and imprisonment within the discretion of the Court having jurisdiction of the Complaint.

SECTION 9: Each day such violation continues shall constitute a separate offense.

SECTION 10: The part or parts of any ordinance or ordinances inconsistent herewith or in conflict herewith are hereby repealed.

SECTION 11: This Ordinance shall take effect immediately after final passage and publication according to law.
