

AN ORDINANCE TO PROVIDE FOR ONE WAY TRAFFIC
ON WAVECREST AVENUE AND SEAFOAM AVENUE, IN THE
TOWNSHIP OF WINFIELD AND TO MAKE WAVECREST
AVENUE AND SEAFOAM AVENUE THROUGH STREETS.

BE IT ORDAINED by the Township Committee of the Township of
Winfield:

SECTION 1: Wavecrest Avenue, commencing at the Easterly inter-
section with Seafoam Avenue, about 200 feet from Stiles Street, to its
Westerly intersection with Seafoam Avenue at Riverview Terrace, is
hereby designated as a one way street and traffic thereon shall move
in a general Westerly direction from Seafoam Avenue along Wavecrest
Avenue to Riverview Terrace and the Easterly point of intersection of
Wavecrest Avenue with Seafoam Avenue.

SECTION 2: Seafoam Avenue, commencing at its Westerly inter-
section with Wavecrest Avenue, at Riverview Terrace, to its Easterly
intersection with Wavecrest Avenue, about 200 feet from Stiles Street,
is hereby designated as a one way street and traffic thereon shall
move in a general Easterly direction from the intersection of Seafoam
Avenue and Wavecrest Avenue at Riverview Terrace along Seafoam Avenue
to its intersection with Wavecrest Avenue, about 200 feet from Stiles
Street.

SECTION 3: Seafoam Avenue and Wavecrest Avenue are hereby
designated as through traffic streets.

SECTION 4: All ordinances or parts of ordinances inconsistent
herewith are hereby repealed.

SECTION 5: For any violation of the provisions of this ordinance
any offender shall be subject to a fine of not more than Fifty (\$50.00)
Dollars or to imprisonment for a term not exceeding thirty (30) days,
or both such fine and imprisonment within the discretion of the court
having jurisdiction of the complaint.

SECTION 6: This ordinance shall take effect immediately after
final adoption and publication according to law.
