AN ORDINANCE TO ESTABLISH AUTOBUS STOP LOCATIONS IN THE TOWNSHIP OF WINFIELD

BE IT ORDAINED, by the Township Committee of the Township of Winfield:

SECTION 1: For the welfare and safety of all persons entering or alighting from autobuses within the corporate limits of the Township of Winfield bus stops are hereby established at the following locations:

- A. Northwest corner of Winfield Place.
- B. Between No. 38 and No. 40 on the northerly side of Wavecrest Ave.
- C. Between No. 56 and No. 58 on the northerly side of Wavecrest Ave.
- D. Between No. 72 and No. 74 on the northerly side of Wavecrest Ave.
- E. Between No. 80 and No. 82 on the northerly side of Wavecrest Ave.
- F. Between No. 88 and No. 90 on the northerly side of Wavecrest Avenue, near the corner of West Pass.
- G. Between No. 100 and No. 102 on the northerly side of Wavecrest Avenue.
- H. Between No. 118 and No. 120 on the northerly side of Wavecrest Avenue near the corner of Riverview Terrace.
- I. Between No. 43 and No. 45 on the southerly side of Seafoam Ave.
- J. Between No. 29 and No. 31 on the southerly side of Seafoam Avenue, near the corner of East Pass.
- K. At No. 17 on the southerly side of Seafoam Avenue.
- L. At No. 9 on the southerly side of Seafoam Avenue.
- M. At No. 1 on the southerly side of Seafoam Avenue.
- N. Opposite 2 Seafoam Avenue on the southerly side of Seafoam Avenue.
- O. Between No. 10 and No. 12 on the northerly side of Wavecrest Avenue, opposite Atlantic Drive.
- P. At No. 28-B on the east side of Winfield Place.

SECTION 2: The above mentioned established bus stops shall be properly designated as required by law and the Public Safety Director of the Township of Winfield is authorized from time to time to make minor changes in the location of the aforementioned bus stops as the welfare and safety of the persons using the said buses may require or as the welfare and safety of persons and vehicles using the public highways mentioned may require or as required by law.

SECTION 3: The bus stops at the locations indicated shall each be fifty (50') feet in length and of sufficient width to accommodate the vehicles using the same.

SECTION 4: No person shall stop or park any vehicle in or upon any part of the aforementioned established bus stops or directly or

indirectly interfere with the use thereof by auto buses lawfully authorized to use the public heighways within the corporate limits of the Township of Winfield.

SECTION 5: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 6: For any violation of the provisions of this ordinance any offender shall be subject to a fine of not more than Fifty (\$50.00) Dollars or to imprisonment for a term not exceeding thirty (30) days, or both such fine and imprisonment within the discretion of the court having jurisdiction of the complaint.

SECTION 7: This ordinance shall take effect immediately after final adoption and publication according to law.
