

AN ORDINANCE TO AUTHORIZE THE APPOINTMENT OF A DEPUTY CLERK IN THE TOWNSHIP OF WINFIELD AS AUTHORIZED UNDER CHAPTER 322 OF THE LAWS OF 1953 AND TO AMEND AN ORDINANCE CREATING THE POSITION OF SECRETARY TO THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WINFIELD, BEING AN ORDINANCE OF SAID TOWNSHIP NO. 40.

BE IT ORDAINED by the Township Committee of the Township of Winfield:

SECTION 1. As authorized under the provisions of Chapter 322 of the Laws of the State of New Jersey for the year 1953, the Township Committee of the Township of Winfield shall be authorized to appoint a Deputy Clerk for the Township of Winfield for the term provided for by law.


SECTION 2. The purpose of the appointment of said Deputy Clerk shall be to have someone with legal authority in charge of and in attendance at the office of the Clerk of the Township of Winfield during all normal business hours because the position of Clerk of the Township of Winfield is a part-time position and this provides for such attendance for the convenience and welfare of the public having business with said office during the normal business hours thereof.

SECTION 3. The Deputy Clerk so designated by the Township Committee shall also be known as the Secretary of the Township Committee and shall have the qualifications as set forth in Ordinance No. 40 heretofore adopted by the Township Committee creating the position of Secretary to the Township Committee and said Deputy Clerk and Secretary to the Township Committee shall receive such compensation as has heretofore been authorized by the Township Committee by Ordinance or as is hereinafter authorized by ordinance of the Township Committee.

SECTION 4. The said Deputy Clerk and Secretary to the Township Committee shall have all of the authority to perform the duties of such office as designated and authorized by law.

SECTION 5. All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistent part or parts thereof.

SECTION 6. This ordinance shall take effect immediately after final adoption and publication according to law.
